New Business, Agenda Item 1, "Mead & Hunt Monthly Progress Report". – The Mead & Hunt progress report-summarizing activities for the period from August 1, 2023, through August 31, 2023, was presented for Committee review.

**New Business Agenda Item 2, "Water/Sewage Report."** – For the period from August 14, 2023, to September 13, 2023 (30 days) daily I&I was 1,811 gallons. For the same time period in 2022, I&I was 2,438 gallons. For the period from August 14, 2023, to September 13, 2023 (30 days) water loss was (134,782) gallons. For the same time period in 2022 water loss was (101,460) gallons.

New Business Agenda Item 4, "Airline Monthly Statistics." – For the month of August 2023, SkyWest enplaned 2,674 passengers and deplaned 2,626. Last year in August SkyWest enplanements were 2,494 compared to this year's enplanements of 2,674 an increase of 180 passengers or 7%. SkyWest experienced 1 cancellation during the month compared to 1 in August of 2022.
